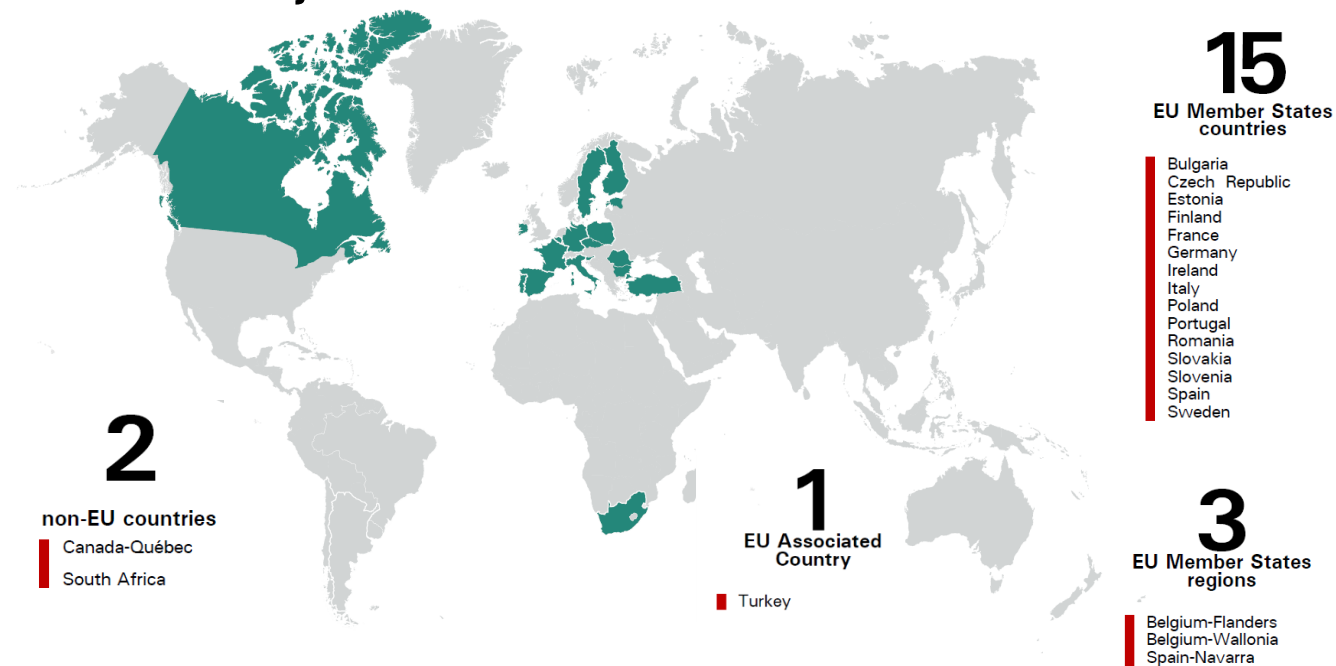
1. Secure the sustainable and responsible supply of **non-food, non-fuel mineral raw materials** for a **carbon-neutral and a circular economy**
2. Promote **world-wide** research and innovation (R&I) cooperation through **coordinated funding**
3. **Reduce the fragmentation of R&I** funding across Europe and globally
4. Implement **Joint Calls** for transnational R&I projects on **“Raw materials for the sustainable development and the circular economy”**
5. Support **international R&I projects** between universities, research institutes, small, medium and large enterprises, NGOs, public authorities, etc

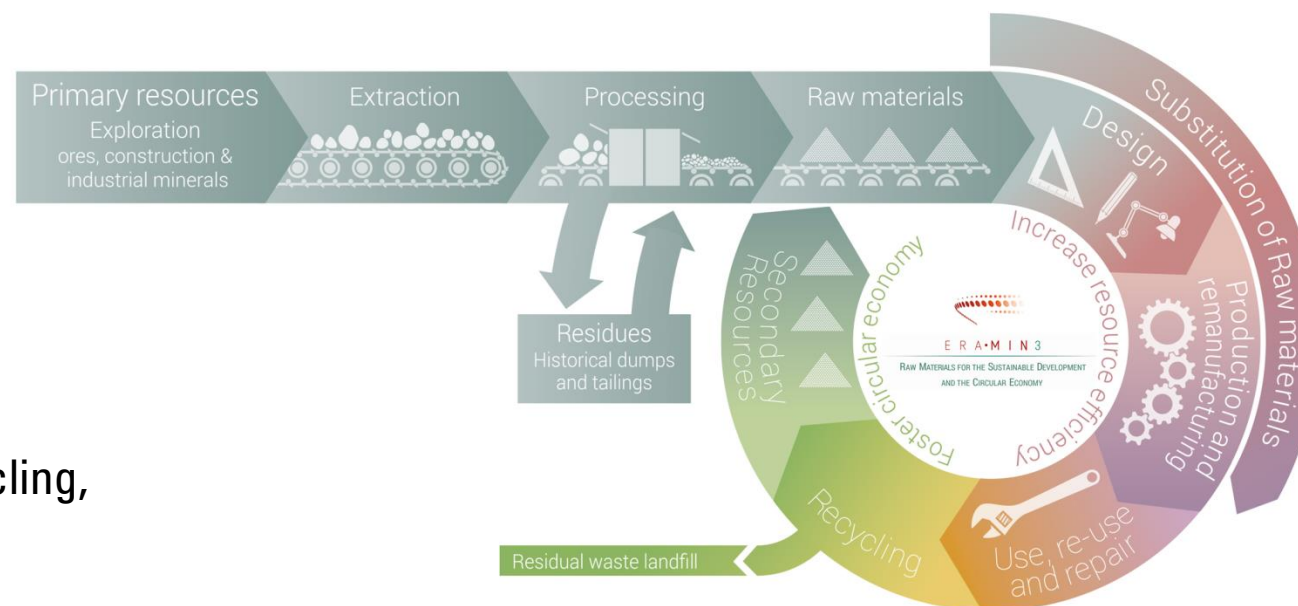

June 15, 2021	Communication of pre-proposal assessment
September 1, 2021	Deadline for full-Proposal submission
November 30, 2021	Tentative communication of full-proposal assessment
December 14, 2021	Selection of full-proposals recommended for funding
May 1, 2022	Latest starting date of selected projects

Elegibility criteria

Eligible legal entities:

- Universities
- Research institutes
- SMEs, large industry
- NGOs
- Public authorities

Eligible research (TRL 1-9):

- Fundamental
- Applied research
- Innovation

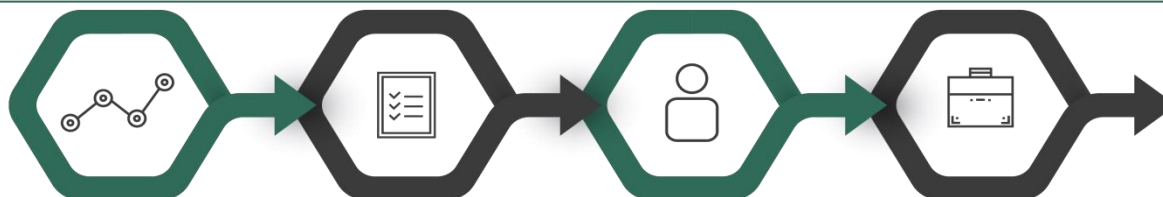
Minimum Consortium: **3 partners** requesting funding from **3 countries** whereof **2** are **EU Member State or an Associated Country (Turkey)** named in this Call

Applicants requesting funding must **comply with the national/regional funding criteria and regulations** of their respective Funding Organisation

Applicants not requesting funding must provide evidence of the availability of their own funds to cover their project costs.

At least **half of the partners** in a consortium must belong to countries participating in the Call.

Project duration: **12 - 36 months** (subject to national/regional rules)



H2020 evaluation criteria:

1. Excellence
2. Impact
3. Implementation

Selection of project for funding through a ranking list from an international scientific assessment of proposals

Variable funding rates:

- 100 % for non-profit organisations
- <70% for profit organisations

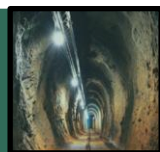

Topics

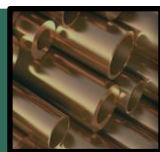
Proposals can only address **more than one main topic** and more than one of the 20 sub-topics, subject to national/regional regulations

The inclusion of the **cross-cutting topics** in proposals is of **added value**



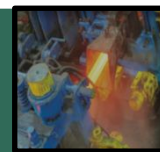

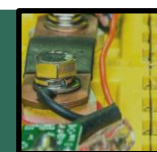

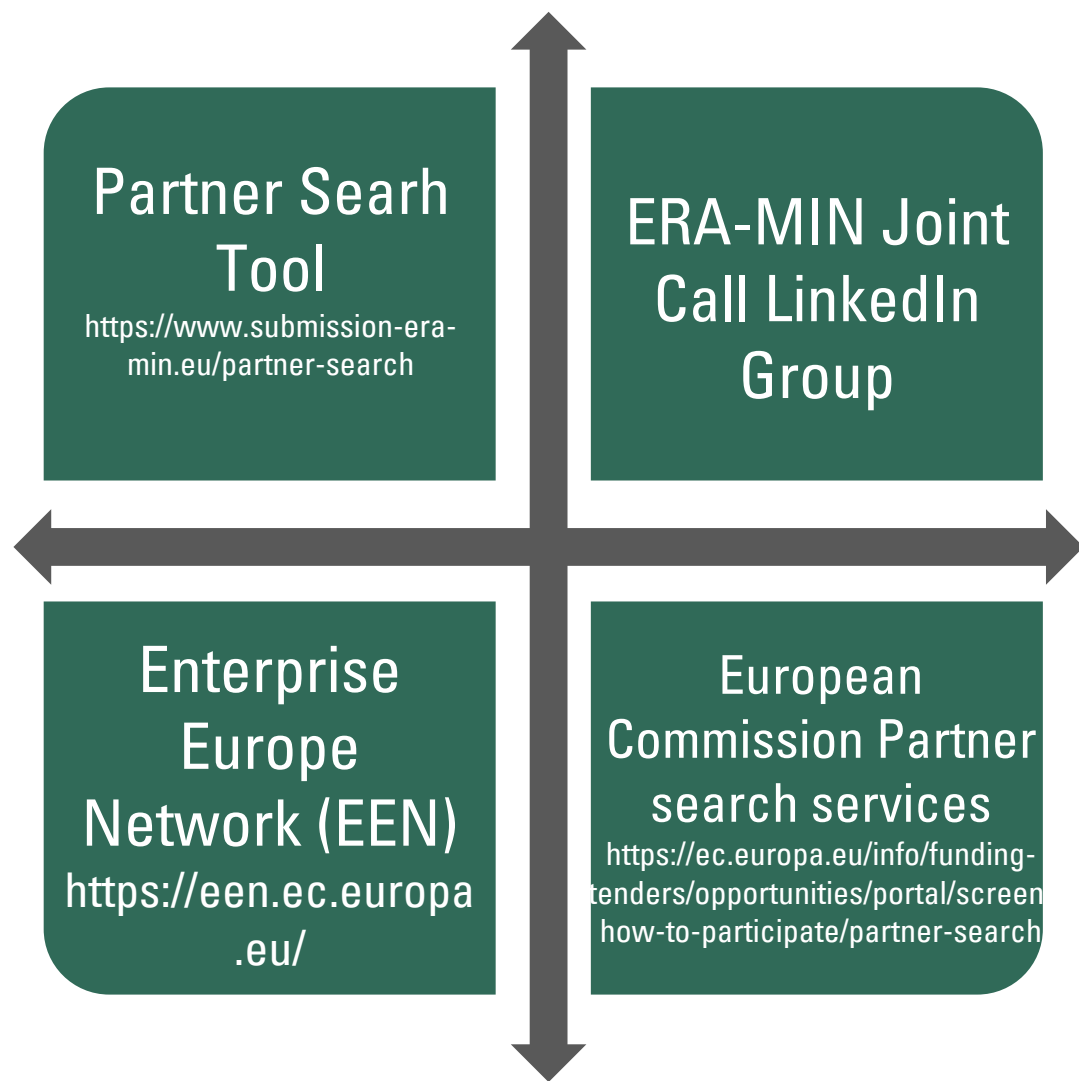
