

- 5. Improve the competitiveness and the environmental, health and safety performance of non-fuel, non-food RM operations.

















Joint Call 2021

Eligibility criteria

Eliqible legal entities:

- Universities
- Research institutes
- SMEs, large industry
- NGOs
- Public authorities

Eligible research (TRL 1-9):

- **Fundamental**
- Applied research
- Innovation

Minimum Consortium: 3 partners requesting funding from 3 countries whereof 2 are EU

Member State named in this Call or an Associated Country (Turkey)

Applicants requesting funding must comply with the national/regional funding criteria and regulations of their respective Funding Organisation

Applicants not requesting funding must provide evidence of the availability of their own funds to cover their project costs.


At least half of the partners in a consortium must belong to countries participating in the Call.






