**ERA-MIN 2** comprises a progressive, pan-European network of 21 public research funding organisations from 18 countries/regions (Argentina, Belgium-Flanders, Brazil, Chile, Finland, France, Germany, Ireland, Italy, Poland, Portugal, Romania, Slovenia, South Africa, Spain, Spain-Castilla y Léon, Sweden and Turkey).

Built on the experience of the EU project ERA-MIN (2011-2015), **ERA-MIN 2** aims to enhance and strengthen the coordination of research and innovation programmes in the field of non-energy, non-agricultural raw materials (construction, industrial and metallic minerals) to support the European Innovation Partnership on Raw Materials, the EU Raw Materials Initiative and further develop the raw materials sector, in Europe and globally, through funding of transnational research and innovation (R&I) activities.

**ERA-MIN 2** will support demand driven research on primary and secondary resources, and substitution of critical raw materials under a circular economy approach, to give the opportunity to the R&I community to apply to world-wide coordinated funding, gaining access to leading knowledge and new markets, while reducing fragmentation of R&I funding across Europe and globally. This will be achieved through one EU co-funded call for R&I proposals in 2017 and two additional calls, in 2018 and in 2019, designed and developed specifically for the non-energy, non-agricultural raw materials sector.

## 1. Executive summary

The report presents the implementation of the Communication and Dissemination Plan. The strategy is to maximize impact by reaching final target audience, at appropriate times, via appropriate channels, with sustained interaction and always aiming at sustainable use of results. This report is intended to summarize the tasks and outcomes carried out up to this moment.

Communication and dissemination covers three contexts.

- Partners' information sharing and exploitation where partners and Observer organisations organize their contribution to ERA-MIN 2 impact enhancement.
- Processes related to dissemination and exploitation over ERA-MIN calls' life cycle, covering from call preparation, announcement, call assessment, projects monitoring and project results.
- General picture of external dissemination actions including a general view of all the actions compiled over the implementation of ERA-MIN 2.

Website is the core of ERA-MIN 2 communication and dissemination. It acts as a tool organized in several sections calls, results, news, events, publications and partner search.

A group of indicators have been established in the Communication and Dissemination Plan. In this interim report, indicators based assessment is presented. A review of indicators and measurements associated is foreseen.

Finally, a complete compilation of dissemination actions is presented in four appendixes.

#### 2. Framework

This report presents the impact enhancement of ERA-MIN 2 supported by dissemination activities. The main goal is the transnational projects' outcomes and lessons learnt reaching relevant stakeholders.

Methodology is based on the implementation of the Communication and Dissemination Plan [D5.2]. The strategy is to maximize the impact by reaching relevant stakeholders at appropriate times, via appropriate channels, with sustained interaction and always aiming at sustainable use of results.

Targets of dissemination and exploitation have been identified: ERA-MIN 2 partners, networks and research sector, EU funded projects, industry and general audiences.

Channels and tools take into account the type of target and activity. Main channels are website, social networks, Email and newsletter. On the other hand, seminars and workshops are prepared for specific contacts with stakeholders.





Procedures to prepare, carry out the activities, provide feedback and extract conclusions are considered for the most elaborated dissemination activities.

Other elements for dissemination and exploitation, such as leaflets and posters, are part of the dissemination strategy.

The information will be organized taking into account the context in which data are exploited.

In this report, a comprehensive compilation of dissemination actions are presented.

## 3. Dissemination and exploitation processes

Different contexts are handled. Each context has required a specific approach to enhance the impact in a proper manner. The following contexts are identified:

- Partners' information sharing and exploitation
- Processes related to dissemination and exploitation over ERA-MIN calls' life cycle
- General picture of external dissemination actions

#### 3.1. Internal sharing and exploitation

ERA-MIN 2 brings together 21 partners from 17 countries/regions from four continents. A heterogeneous group that has to act jointly in one voice. They provide ERA-MIN 2 with very valuable information in terms of national/regional initiatives, cutting-edge fields or topics, research or industry events and experts or networks. All this information is helpful for ERA-MIN 2 purposes accomplishment.

Apart from being used as source of information, **sharing information** support discussions and documentation generation that **improve the impact**. Different channels are used in this environment: mailing, teleconferences, face to face meetings and the partner area in ERA-MIN 2 website.

Mailing is basic for coordination, scheduling and arrangements. Dozens of email conversations per month are generated in this context. The key point is to reach the correct people, for this purpose mailing lists are created and continuously updated. They cover a good range of purposes, such as, financial/administrative, management, WP/Tasks implementation, call processes, observers contacts, experts in different fields discussions, etc. They are initiated by any partner and controlled by the coordinator. Each piece of information has to reach the correct targets and the necessary active actors have to be engaged in the conversations.

**Teleconferences** are arranged **periodically or by notice** when necessary. The average is **more than a teleconference per quarter** to deal with common project management issues. A higher number of these meetings is arranged when calls life cycle or additional activities implementation require discussions or quick decision making. They **complement mailing** 





purposes providing comprehensive and immediate resolutions even when partner's consensus, voting or agreement is necessary.

Face to face meetings are bi-annual but very helpful to improve personal communication and confidence to work as a team. Eight face to face meetings have been held since the kick-off meeting in Brussels. They are mostly related to Network Steering Committee (NCS) and Call Steering Committee (CSC). The NSC meetings cover the ERA-MIN 2 work packages review and planning whereas the CSC meetings are specific related to decision-making in Joint calls..

It is important to highlight that **Observer organisations (non-partners) and guests** were invited to participate in some of the meetings. This contributes to **improve the dissemination** of ERA-MIN 2 outcomes among different stakeholders outside the project, such as, funding organisations or experts.

Finally, "Partner Area" in the website is the repository supporting information access and sharing among partners. It is intended to **facilitate the collaboration and information sharing** related to the project activities between partners. The Partner area is continuously updated by the Communication team managed by AEI.




FIGURE 1.- PARTNER AREA CONTENT

In Figure 1, a view of the content included in the Partner area is presented.

The repository is the archive of the project supporting internal sharing and exploitation of the project by partners.

#### 3.2.ERA-MIN Calls context

Processes related to dissemination and exploitation over ERA-MIN calls' life cycle are directly related to the stage of the joint call. Some of them overlap from one call to the next, but each stage specific dissemination and exploitation actions are designed to accomplish impact enhancement.

**3.2.1.** <u>Selection of thematic priorities and establishment of the scope of a call</u> Priorities were selected on the basis of the integrated strategy proposed in the EU Raw Materials Initiative (RMI) and the Strategic Implementation Plan of the European Innovation Partnership (EIP) on Raw Materials as well as in priorities of national/regional funding programmes participating in the call. The ERA-MIN Advisory Board provided inputs to ensure topics are relevant to key actors and EU goals. **Workshops and seminars** were the instruments used to improve the impact in thematic priorities selection.




FIGURE 2.- ERA-MIN 2 PRIORITIES IN CIRCULAR ECONOMY

It was agreed to follow a circular economy (Figure 2) approach by addressing production, consumption, waste management and the field "from the waste to resources". This **main** idea is delivered at meetings, events and in the website through dissemination material, such as, flyers, posters or newsletters.

The establishment of the scope of a call was agreed by the CSC. Advisory Board advice and national/regional priorities of the partners were taken into consideration. The scope covers the call topics description and the expected impact. Regarding dissemination and exploitation areas, most of the processes at this stage are handled by the consortium as





part of the internal sharing and exploitation. Pre- and announcement and promotion of a call is then carried out.

Different channels are used in this environment: events, webinars/seminars, meetings with National Contact Points (NCP), partner networking and partner websites and ERA-MIN 2 website. The main idea is to use different fora to reach stakeholders at regional, national and international level. A great effort in dissemination was made at this stage to raise awareness among potential applicants to open joint transnational calls (Appendix I). Firstly, specific content is created on the website. Secondly, partners prepare and present the call in meetings, events, webinars/seminars. Created resources are then allocated in the website or even in external platforms like YouTube.

Figure 3 present examples of announcement and promotion of calls by dissemination in different areas of the website (calls area and publications area).

**Call area** on ERA-MIN 2 website is the main source of information regarding call pre- and announcement as well as publication of call documents and access to online proposal submission. It has been designed to give a complete information on Joint Call, namely, provide participants access to:

- Call calendar
- Call documents
- Call scope and topics
- Partner search tools
- Participant countries and regions

Apart from this information, direct contact with partners contact points is always available for applicants to clarify issues on national/regional funding rules and regulations. The information about ERA-MIN 2 partners and contact persons can be found in the "about us" tab.

#### 3.2.2. <u>Call monitoring and assessment</u>






**Regarding dissemination, exploitation and impact,** call monitoring and assessment processes cover from the beginning of a project until the end and further. In this environment, the information obtained from monitoring is used to disseminate ERA-MIN complete project portfolio. Indeed, Final reports of the ERA-MIN R&I projects funded by the previous ERA-MIN project (2011-2015) are disseminated within ERA-MIN 2 and this information can be exploited.

Main sources of call monitoring are:i) monitoring each 6 months of funded projects; ii) annual project reports, iii) presentations made by project coordinators at the Mid-term Seminar (Appendix II) and iv) a future Final Conference. These dissemination events intended to improve ERA-MIN 2 impact because they are open to all partners of ERA-MIN 2, CSC and invited stakeholders. These events also promoted networking between funded projects from which synergies and complementarities could be explored in future research projects or end-users.

A wider dissemination is implemented by partners in relevant fora (Appendix III). The website has an area intended to compile all the projects' results. It is the core of ERA-MIN 2 outcomes dissemination.

From the beginning of the project the following project results have being generated and are available at **Results area** on the website (Figure 4).





The project's results and call statistics have been disseminated to larger audience through ERA-MIN 2 newsletters.

The final reports of projects funded through ERA-MIN Joint Call 2015 will be published from March 2020 since a few projects have only ended in December 2019.

Finally, it is important to remark that lessons learnt in calls are compiled and analysed and then used for improvement of new calls. These lessons are included in the partner area for consortium use.





#### 3.3. General picture of dissemination actions

All the partners are intended to work on dissemination actions. ERA-MIN 2 partners have done a great effort regarding dissemination. Compiled actions can be seen in Appendix III. These actions are mainly related to previous section but not only.

As presented in previous sections, website take advantage of partners contribution and ERA-MIN 2 work packages implementation. In this sense, the website is a tool to improve impact. The website reinforces communication and dissemination by adding information of interest to improve impact. Tabs "News", "Events" and "Publications" cover this objective.

Inputs for "News" and "Events" sections are provided by all the partners and project coordinators. "News" section is updated very often and include references directly related to ERA-MIN 2 or its projects as well as other news of interest for the raw materials research community (Figure 5). "Events" area disseminate conferences, matchmaking events, Infodays and other raw materials related events and activities of which some are from other EU raw materials projects such as SCRREEN or PROMETIA.




FIGURE 6.- PUBLICATION CONTENT EXAMPLE

#### Twitter overview

ERA-MIN2 has published 291 Tweets, having gotten more than 14.9K impressions in a period of 91 days (3 months approximately), and an average of 164 impressions per day during the last 3 months.

Twitter account has 341 followers, increasing every day.



Regarding the impact per country, the next figure showed a high impact of followers and viewers in Spain, Belgium and Germany at the top 3. The rest of the EU countries showed a similar percentage of the audience, about 5-6%.




FIGURE 9.- TWITTER INDICATORS

## 5. Conclusions

Communication and dissemination activities cover the objectives identified in the Communication and Dissemination Plan. All project's partners have contributed to leverage their national and regional networks. Apart from that, the partners appointed to have reached the corresponding target groups: i) other partners, ii) ERA-MIN 2 Observers, iii) key networks and iv) research sectors.

Regarding internal communication, the partner area has been created in the website, meetings have been periodically organised some of them face-to-face meetings arranged to coincide with events in the area.

External communication is continuously supported by the public area of the ERA-MIN 2 website (<u>www.era-min.eu</u>). The following sections have been created for this purpose: news, results, calls and events. The website is systematically updated in close cooperation with partners. Social media channels have been created (twitter and LinkedIn) to extend the scope of communication and dissemination.

The results area is a comprehensive portfolio of ERA-MIN 2 outcomes mainly focused on projects outcomes but covering other issues around the projects too, such as, statistics, topics, project budget, and countries involved, period of execution, etc.

The section "Boost" provides the stakeholders with an open space for comments.

Cooperation with other initiatives and projects is key for communication and dissemination. Direct contacts and participation in events organized by other initiatives and projects are part of ERA-MIN 2 core activities.

# Mid-term seminar with the 16 projects supported by the EU co-funded ERA-MIN Joint Call 2017 18 November 2019, Brussels

# Meeting report

#### Context

**ERA-MIN 2** comprises a progressive, pan-European network of 21 public research funding organisations from 18 countries/regions (Argentina, Belgium-Flanders, Brazil, Chile, Finland, France, Germany, Ireland, Italy, Poland, Portugal, Romania, Slovenia, South Africa, Spain, Spain-Castilla y Léon, Sweden and Turkey).

The **ERA-MIN Joint Call 2017** was successfully launched in a 2-step submission procedure with a provisional call budget of € 15 million (including European Union contribution) and the participation of 17 countries: Argentina, Belgium/Flanders, Brazil, Chile, Finland, France, Germany, Ireland, Italy, Poland, Portugal, Romania, Slovenia, Spain, Sweden, South Africa, Turkey. Out of the 94 pre-proposals submitted, 16 projects were funded. The procedure for reporting and monitoring includes two meetings with all projects: mid and final seminars.

At the level of ERA-MIN2, for each of the funded projects, one project officer (PO) was appointed from the funding agency of the project coordinator. S/he is responsible with:

- obtaining information on the short term implementation of the project;
- assuring the link of the project's implementation and the ERA-MIN2 consortium;
- providing support when needed, in terms of difficulties (deviations, delays etc.).





Project officers were present during the seminar with the objective of clarifying any issue resulting from the mid-term presentations; project officers had access, prior to the meeting, to the annual reports and 1<sup>st</sup> (6 months) and 2<sup>nd</sup> status (18<sup>th</sup> months) reports.

For the mid-term seminar, ERA-MIN2 also invited the project officer from the EC (Mr. Jonas Hedberg) and the Chairperson of the Scientific Evaluation Board (Mr. Patrice Christmann) in order to keep track with the development of the projects. The mid-term meeting was held at Hotel le Plaza, in Brussels, on 18<sup>th</sup> November 2019 with the following objectives:

- take stock of the progress of the projects at the middle of their lifetime;
- provide help by answering questions from project coordinators;
- help the projects to optimally use the second half of their lifetime;
- provide an opportunity for projects to find synergies and create networks.

Each project coordinator (PC) was invited to present orally the project. For good presentations of projects, they were grouped in the four main call topics:

- 1. Supply of raw materials from exploration and mining
- 2. Design
- 3. Processing, Production and Remanufacturing
- 4. Recycling of End-of-Life products.

Even though in the agenda there was a "Questions & Answers" session after all presentations have concluded, for better results, projects coordinators were asked questions right after having done the presentations. This helped both the projects coordinators and stakeholders that asked questions.

#### Opening session

Dina Carrilho (FCT) welcomed everybody to the meeting and thanked them for their participation. Nicoleta Dumitrache (UEFISCDI) opened the seminar with a presentation on Call 2017, objectives of ERA-MIN2 and the objectives of the mid-term seminar.

Projects are presented by coordinators.

#### Conclusions

Dina Carrilho (FCT) thanked all participants, in particular, the project coordinators for their presentations. She expressed her gratitude for having all the 16 projects represented, giving this way opportunities for synergies and networking between the projects and exchange of information with the funding agencies. She also pointed out that:

- Funding agencies and the Call Secretariat are available to be contacted in case of needed support;





- ERA-MIN2 website and Twitter can also be of help in promoting results/conferences/other information regarding the implementation of the projects;
- In the case project extensions are needed, the PC provides the justification to the Call Secretariat who asks the approval of the funding agencies involved and the Call Steering Committee (CSC);
- The publishable summaries of the 16 projects are presented in a Catalogue which pdf format is available on the ERA-MIN 2 website;
- Publishable summaries of the first annual project reports will be uploaded on the ERA-MIN2 site.

This report shows that in terms of common topics addressed, projects LIGHTS, Li+Water and RECEOL are all covering battery related topics. BIOMIMIC and FLOW focus on fly ash whereas BASH-TREAT and INSTANT focus on bottom ash. Synergies were found between METRECYCLE and MAXYCLE. Both projects MetRecycle and FLOW are contribuing for the Strategic Research and Innovation Partnership – Networks for the transition into circular economy (SRIP – Circular economy) in Slovenia.
